Registering for the 2016-2017 School Year

It's hard to believe it, but registration for next year is just around the corner! Registration for current Weekday School families and First Presbyterian Church members will be held on Monday, February 1st. Beginning on February 2nd, current and new Weekday School families will be able to submit Registration Forms. Registration for February 1st and 2nd will take place in Loudoun Hall from 8:30 am to 1:30 pm.

What to bring to Registration:

- A completed Registration Form, and the Commitment Fee (\$55 per child, \$80 for family). A separate deposit to hold your child's place will be due on June 1st. For your convenience, a Registration form is attached.

What about Health Forms and Birth Certificates for New Students?

- Health forms and birth certificates are due to the Weekday School prior to the first day of school. These can be submitted when the Weekday School opens in August, or at the Meet the Teacher Day.

What factors determine class placement?

- Careful consideration is given to the placement of our children. Our goal is to provide a developmentally appropriate education where each child can experience success based on his/her level of development.

Registration is handled on a first come, first served basis.
